THE HUMBLE PETITION OF Gary L. Anderson, D.D., President, William H. Smallman Vice President and John W. Boyes, Jr., Secretary/Treasurer, all of The Baptist Mid-Missions in Jamaica, SHOWETH :


1. THAT your Petitioner desires to present this Honorable House a Private Bill entitled "An Act to amend the Baptist Mid-Missions in Jamaica (Incorporated) Act, 1964 by causing the name of the Act to be changed to The Fairview Baptist Ministries of Jamaica (Incorporated) Act and to transfer ownership and control of real and personal property from Baptist Mid-Missions, incorporated by virtue of the said Baptist Mid-Missions in Jamaica in Jamaica (Incorporated) Act to Fairview Baptist Ministries in Jamaica and the vesting of certain Property in the Body so Incorporated".
2. THAT the object of this Bill is to incorporate the Fairview Baptist Ministries and to constitute the holders of certain Offices in the Fairview Baptist Ministries in Jamaica with perpetual succession and with power to hold and deal with property, and to sue and be sued in its corporate name.
3. THAT a copy of the proposed Bill has been deposited in the Office of the Clerk to the Houses of Parliament with the original of this Petition.
4. THAT the Notice of this Bill has been given three successive publications thereof in its entirety in the Jamaica Gazette dated the 30th day of June, 2011, the 7th day of July, 2011 and the 14th day of July, 2011 copies of which said Gazettes have been affixed to the original of this Petition deposited in the Office of the Clerk to the House of Parliament.
5. THAT your Petitioner has also published a Notice containing a statement of the objects and reasons for the Bill in "The Daily Gleaner" newspaper of the 29th day of June, 2011, which has also been affixed to the original Petition deposited in the Office of the Clerk of this Parliament.

6. THAT your Petitioner to the best of its knowledge, information and belief has complied with the Parliamentary requirements as set out in the Standing Order of this Honourable House of Representatives (S.O No. 85 Private Bills).


