1) Annual Reports

Cabinet considered the Annual Reports of the:

b) Board of Commissioners of the Overseas Examinations Commission

3) Land Acquisition

JAMINTEL Building and the Adjoining Property at the Corner of Duke and North Streets, Kingston

Cabinet gave approval for the acquisition by the Transport Authority of the JAMINTEL Building at 97 Duke Street in Kingston and the adjoining property.

The Transport Authority has outgrown its current accommodations at 107 Maxfield Avenue and 119 Maxfield Avenue in Kingston. After considering various options, the entity has determined that the acquisition of the JAMINTEL Building and the adjoining property would best fit its needs for expanded space for its corporate offices.

4) Report

21st Meeting of the Council of Ministers of the Caribbean Forum of African, Caribbean and Pacific States (CARIFORUM), Grenada, and the CARIFORUM Stakeholders' Consultation with the African, Caribbean and Pacific (ACP) Eminent Persons' Group (EPG) on the Future of the ACP

Cabinet noted a report on the 21st Meeting of the Council of Ministers of the Caribbean Forum of African, Caribbean and Pacific States (CARIFORUM) and the CARIFORUM Stakeholders' Consultation with the African, Caribbean and Pacific (ACP) Eminent Persons' Group (EPG) on the Future of the ACP, held in Grenada on 31 October 2013 and 1 to 2 November 2013, respectively. The report provided summary information on the discussions and decisions at the 21st Meeting of the Council of Ministers of CARIFORUM namely, Governance of CARIFORUM with particular focus placed on its legal framework and the governing rules and procedures; and the CARIFORUM-EU Economic Partnership Agreement, specifically the status of the implementation of the provisions of the Agreement and matters arising from the 2nd Joint CARIFORUM-EU Council. The report also provided summary information on the CARIFORUM Stakeholders' Consultation with the ACP EPG meeting. The report advised that the meeting discussed, among other things, key issues relating to trade, aid, higher education and culture; the Post-2015 Development Agenda; options for diversified partnerships; and geo-strategic issues for the ACP Group.
