CABINET AGENDA ISSUES - 22 JUNE 2015

The House is asked to note the following matters which were considered by the Cabinet at its meeting held on 22 June 2015:

- 1. Contracts:
- 2. Legislation;

Each matter shall be elaborated on in turn.

1. Contracts

(i) Security Services at the Savanna-La-Mar Hospital and Westmoreland Health Department Cabinet approved the variation of a contract, in the amount of \$14,236,803.75, to Guardsman Limited for the provision of private security services at the Savanna-La-Mar Hospital and Westmoreland Health Department, with effect from 15 February 2015 to 30 September 2015.

In October 2012, approval was granted for the award of a contract in the sum of \$41,061,880.00 to Guardsman Limited for the provision of security services at the Savanna-La-Mar Hospital and Westmoreland Health Department for a period of two (2) years from February 2013 to February 2015. The extension of the current contract has become necessary to allow for the procurement process for a new contract to be completed.

(ii) Enterprise Human Capital Management Solution for the Government of Jamaica
Cabinet approved the award of a contract to Quidgest Consultores De Gestao, S.A. for
the supply and implementation of an Enterprise Human Capital Management Solution
(EHCMS) for a period of five (5) years in the amount of US\$4,338,825.52, inclusive of a
provisional amount of US\$300,000.00 for ICT infrastructure to be supplied by the vendor.

The purpose of the EHCMS is to provide more efficient human resource planning and management for the public sector, whereby employment data for each employee would be readily available. The system will include, information on employee records, education data and leave entitlement. The EHCMS will also assist in identifying the skill levels of employees and deploying them in their specialised areas.

(iii) Roads in the Monymusk, Bernard Lodge and Appleton Sugar Dependent Areas (SDAs)

Cabinet approved the award of the following contracts for the rehabilitation of roads under the National Cane Roads Rehabilitation Project Phase 2 of the Sugar Transformation Programme:

- (a) Monymusk Sugar Dependent Area, Clarendon (Package 7) to Build-Rite Construction Company Limited in the amount of \$54,226,100.00;
- (b) Bernard Lodge Sugar Dependent Area, St. Catherine (Package 8) to Build-Rite Construction Company Limited in the amount of \$58,282,399.70; and
- (c) Appleton Sugar Dependent Area, St. Elizabeth (Package 9) to N.F. Barnes Construction & Equipment Company Limited in the amount of \$89,097,886.20.

The National Cane Roads Rehabilitation Project is being carried out through financial support from the European Union. Under the project, approximately 200 kilometres of roads will be repaired to provide improved access for the 'field to factories' transportation of sugar cane, whilst also catering to the commute for the sugar workers and the surrounding communities.

2. Legislation

The Revenue Administration (Amendment) Act, 2015

Cabinet gave approval for the introduction of the Bill entitled the "The Revenue Administration (Amendment) Act, 2015" into the Houses of Parliament.

The Bill seeks to amend the Revenue Administration Act in order to establish a legal framework in domestic law for the facilitation of international tax compliance in keeping with the United States' Foreign Account Transaction Compliance Act (FATCA).

3. Annual Reports
