CABINET AGENDA ISSUES - 17 AUGUST 2015

The House is asked to note the following matters which were considered by the Cabinet at its meeting held on 17 August 2015:

- 1. Contracts;
- 2. Annual Reports;

Each matter shall be elaborated on in turn.

1. Contracts

(i) Crane Services for Wigton Windfarm Limited

Cabinet approved the negotiation of a contract in the annual rental amount of US\$1,398,000.00 to D.M. Equipment Company Limited, for the provision of crane services for Wigton Windfarm Limited, over a ten-year period.

Wigton Windfarm Limited, a subsidiary of the Petroleum Corporation of Jamaica, has operated a windfarm in southern Manchester since 2004. The windfarm supplies clean, low cost electricity to the national grid. Under the second expansion approved by Cabinet, construction is currently being undertaken on the windfarm.

(ii) Procurement of Uniforms and Fabric for the Department of Correctional Services

Cabinet approved the award of a contract in the amount of \$68,560,250.00, to L.P. Azar Limited for the procurement of uniforms and fabric for the Department of Correctional Services.

The staff complement of the Department of Correctional Services includes both uniformed officers and civilians. The salary and fringe benefits arrangements include the provision of uniforms to the correctional officers within the first six (6) months of the financial year. The items being supplied by L.P. Azar Limited include stockings, socks, neck ties and fabric.

2. Annual Reports
