CABINET AGENDA ISSUES – 14 SEPTEMBER 2015

The House is asked to note the following matters which were considered by the Cabinet at its meeting held on 14 September 2015:

- 1. Contracts;
- 2. Legislation;

Each matter shall be elaborated on in turn.

1. Contracts

(i) Motor Vehicles for the Jamaica Constabulary Force

Cabinet approved the award of two contracts totalling \$335,147,246.14, for the procurement of motor vehicles for the Jamaica Constabulary Force (JCF) to:

- 1) Toyota Jamaica Limited in the sum of J\$273,247,246.14 for the purchase of:
 - Forty-seven Toyota Corolla patrol cars;
 - Twenty-seven Toyota Hilux pickups;
 - Four Toyota Rav4 sport utility vehicles;
 - One Toyota coaster bus; and
 - Two Toyota Hiace 15-seater buses.
- 2) Vehicles and Supplies Limited in the sum of J\$61,900,000.00 for the purchase of:
 - Five Isuzu 5-ton troop-carrying trucks; and
 - Four Isuzu 11-ton prisoner-carrying trucks.

The responsiveness of the JCF is severely restricted owing to the deterioration of its motor vehicle fleet, of which 32.6% is out of use and 28.7% are over eleven years old. The acquisition of the vehicles is necessary to enhance the operational and service delivery activities of the JCF and to assist in the fight against crime.

(ii) Provision of Cleaning and Portering Services at the Cornwall Regional Hospital
Cabinet approved the award of a contract in the amount of J\$429,791,949.12 to Milestone
Environmental Limited for the provision of cleaning and portering services at the Cornwall
Regional Hospital for a period of three (3) years.

The cleaning and portering services will help to create a clean and healthy environment at the Cornwall Regional Hospital. The contractor will be expected to provide effective 24-hour cleaning and portering services and will be required to supply all labour, material and supplies, equipment, tools and other items needed.

2. Legislation

The Casino Gaming (Amendment) Act

Cabinet gave approval for a Bill entitled "An Act to Amend the Casino Gaming Act" to be tabled in the Houses of Parliament.

The Bill seeks to amend the Casino Gaming Act to remove errors and omissions which are inconsistent with the principal objectives of the Act. The amendments include increasing the power of the Commission, granting a Casino Gaming Operator an option to discharge its liability with respect to disciplinary actions proposed to be taken against it, and widening the scope of persons deemed to be connected to the applicant for the purposes of determining if a person is fit and proper to be concerned in the operation of a casino.

3. Land Matters

(i) Acquisition of part of Palmetto Cottage and the Pinnacle now called De La Vega Heights. St. Catherine

Cabinet gave approval for the acquisition of lots, at a total cost of \$27.5 million, by the Government of Jamaica for the purpose of developing the property as a Rastafarian heritage site and cultural centre.

The lots being acquired form part of what is now known as De La Vega Heights, St. Catherine which is regarded as the birthplace of the Rastafarian faith and is of great significance to Jamaicans, Rastafarians and Pan-Africans. On 12 September 2013, the Jamaica National Heritage Trust (JNHT) declared Lot 199 as a National Monument to preserve and maintain the integrity of the site. The Trust also recommended that the declared lot and lots in the periphery be acquired for the purpose of accessibility to the heritage site.

(ii) Sale of Lands Located at Phoenix Park Dunbeholden, St. Catherine

Cabinet gave approval for the sale of 142.16 hectares (351.28 acres) of lands by SCJ Holdings Limited to Gore Developments Limited, at a sale price at \$579.612 million. The lands are located at Phoenix Park, Dunbeholden in the parish of St. Catherine.
