# 4 Jamaica's Signing of the Paris Agreement Under the United Nations Framework Convention on Climate Change (UNFCCC)

Cabinet gave approval for Jamaica's signature of the Paris Agreement under the United Nations Framework Convention on Climate Change at the High-level Signing Ceremony at the United Nations Headquarters, New York on 22 April 2016. Cabinet also authorized the Minister of Foreign Affairs and Foreign Trade to sign the Agreement on behalf of the Government of Jamaica.

The Paris Agreement is a legally binding instrument which requires countries to limit the increase in the global average temperature to well below 2°C above pre-industrial levels by 2100 and pursue efforts to limit the temperature increase to 1.5°C above pre-industrial levels. The ultimate objective of the Agreement is to stabilize greenhouse gas concentration in the atmosphere at a level that will prevent dangerous interference with the climate system.

#### 5 Celebration of Workers' Week and Labour Day 2016
