CABINET AGENDA ISSUES - 2 MAY 2016

The House is asked to note the following matters which were considered by the Cabinet at its meeting held on 2 May 2016:

1. Contracts

(i) <u>Variation of Contract with Champion Industrial Equipment and Supplies Limited for the Supply and Installation of Pumps and Pump Houses at the Ebony Park and Spring Plains Agro-Parks Cabinet approved a variation in the amount of \$1,976,557.26, to the contract awarded to Champion Industrial Equipment and Supplies Limited, for the supply and installation of pumps and pump houses at the Ebony Park and Spring Plains Agro Parks under the Agricultural Competitiveness Programme. The original contract amount was \$72,906,132.93.</u>

The variation was necessitated by the requirement to lower the turbine by an additional 10 feet, to maintain safe yields from the well due to the prolonged drought conditions, as recommended by the Water Resources Authority.

(ii) <u>Variation of Contract with TWD Technologies Limited for a T-2 De-Ethanizer Tower</u>

<u>Replacement at Petrojam Limited</u>

Cabinet approved the variation to a contract awarded in September 2012 for the T-2 De-Ethanizer Tower Replacement in the amount of US\$165,312.00 to a contract awarded to TWD Technologies Limited. The original contract amount was US\$539,853.00.

The variation was necessitated by delays which occurred primarily due to excursions in the levels of chlorides and sulphides which impacted the kind of materials used and the approach to the construction going forward.

(iii) Contract for the Refurbishing and Renovation of the Donald Sangster Building, 116 East Street, Kingston, for Tax Administration Jamaica

Cabinet approved the award of a contract for the refurbishing and renovation of the Donald Sangster Building, 116 East Street, Kingston for Tax Administration Jamaica in the amount of \$498,585,093.58 to HDB Construction Limited.

The renovation/refurbishing falls under the Fiscal Administration Modernization Program (FAMP) project, which is financed by the Inter-American Development Bank, and aims to support the Government of Jamaica in achieving a sustainable fiscal position through strengthening institutional capacity to effectively improve tax collection. This particular activity will allow for numerous staff, presently housed in various locations, to be co-located to reduce costs and improve efficiency and productivity.

(iv) Hounslow Water Supply Rehabilitation and Upgrading Project (Phase 2) Hounslow Well to Newell Square Transmission Mains Replacement, National Water Commission Cabinet approved the award of a contract in the amount \$63,185,294.00 to Surrey Paving & Aggregate Company Limited for the replacement of transmission mains from the Hounslow Well to Newell Square.

This project represents part of the National Water Commission's efforts to extend its customer base by supplying potable water to more people. The project will benefit the communities of: Hounslow, Newell, Watchwell, Williamsfield, Hopewell, Short Hill, Great Bay, Calabash Bay; and prospective customers in Fort Charles and the surrounding environs in South West St. Elizabeth.

(v) <u>Dornoch and Greater Dornoch Water Supply Rehabilitation and Upgrading Project, Baron Hill Reservoir to Samuel Prospect Transmission Main Replacement, National Water Commission Cabinet approved the award of contract in the amount \$63,849,360.00 to Alcar Haulage and Construction Company Limited contract for the replacement of transmission mains from the Baron Hill Reservoir to Samuel Prospect.</u>

Through this project, the National Water Commission will continue rehabilitation and upgrading works to the potable domestic water supply in Trelawny.

2. Legislation

The Jury (Amendment) Act, 2016

Cabinet gave approval for the Bill entitled "The Jury (Amendment) Act, 2016" to be tabled in the Houses of Parliament.

The objective of the Act is to provide for a verdict of not less than five jurors for non-capital murder, thereby correcting the existing anomaly that only unanimous verdicts would be acceptable in trials for non-capital murders; and that, where offences were being joined which arose out of the same facts but were subject to differing sentencing regimes, the number of peremptory challenges allowed would be four.
