1. Contracts

(i) Provision of External Audit Services for the Bank of Jamaica

Cabinet approved the award of a five-year contract in the amount of \$78,389,196.00 to KPMG, for the provision of external audit services for the Bank of Jamaica.

The contractor will be required to conduct audits on the Bank's financial statements in compliance with the International Standards on auditing and International Financial Reporting Standards.

(ii) Implementation of the Elhydro Kleenoil Bypass Filtration System in the Jamaica Urban

Transit Company Fleet of Buses

Cabinet approved the award of a contract in the amount of \$251,050,000.00 to Elhydro Inc for the provision of technical professional advice, materials and to perform all operations for the Phase I implementation of the Elhydro Kleenoil Bypass Filtration System in the Jamaica Urban Transit Company fleet of buses.

The use of the Elhydro Kleenoil Bypass Filtration System by the Jamaica Urban Transit Company bus fleet is projected to reduce costs by reducing the time for servicing of buses and reducing engine wear.

2. Annual Reports

Cabinet noted the Annual Reports for the:

The Public Sector Monitoring Committee is being reconstituted to serve as the key mechanism to ensure the implementation of the terms of labour agreements.

 Hosting of the High-Level Symposium on International Maritime Development, the Senior Maritime Administrators' Workshop and Caribbean Memorandum of Understanding on Port State Control Technical Workshop

Cabinet approved Jamaica's hosting of the following International Maritime Organisation (IMO) events over the period 25 February to 1 March 2019:

- i. a High-Level Regional Symposium on International Maritime Development;
- ii. a Senior Maritime Administrator's Regional Workshop over the period; and
- iii. a Caribbean Memorandum of Understanding (CMOU) on Port State Control's Technical Standing Working Group (TSWG) meeting.

The events will be hosted by the Maritime Authority of Jamaica (MAJ) in Montego Bay, St. James, and are part of the IMO's regional project to support maritime development in the Caribbean.

6. <u>Allocation of Financial Resources to Conduct Vector Control Activities in Communities to Support the Dengue Mitigation Actions of the Government of Jamaica</u>

Cabinet approved the allocation of \$55.7 million to the Members of Parliament to undertake vector control activities within their Constituencies through their respective Municipal Corporations, and the allocation of \$100 million to the 13 Municipal Corporations.

The current increase in incidences and suspected incidences of Dengue have necessitated a strong preventative response from the Government of Jamaica.

7. Reports

(i) The Sustainable Blue Economy Conference

Cabinet considered a report from the Ministry of Foreign Affairs and Foreign Trade on the outcomes of Jamaica's participation in the Sustainable Blue Economy Conference held in Nairobi, Kenya, during the period 26 to 28 November 2018.

The report indicated that the Conference provided a platform to explore the full range of opportunities in the oceans, seas, rivers and lakes, for economic development, job creation and poverty eradication.

The report provided information on the delegation, led by the Minister of State in the Ministry of Foreign Affairs and Foreign Trade; the leaders' commitment segment; the key outcomes of the conference encapsulated in the Nairobi Statement of Intent on Advancing a Sustainable Blue Economy; the bilateral meeting between the Minister of State and the Kenyan Cabinet Secretary for Foreign Affairs, Ambassador Monica Juma; the meeting with the Jamaican Diaspora in the Nairobi Metropolitan Area; and other meetings in the margins of the conference.

(ii) International Road Federation's 70th General Assembly and the Road2Tunnel Conference

Cabinet considered a report from the Ministry of Transport and Mining on the participation of the Minister of Transport and Mining in the 70th General Assembly of the International Road Federation (IRF), Board of Director's Meeting and the Road2Tunnel Conference and Expo held in Las Vegas, United States of America (USA) during the period 7 to 9 November 2018.

The report provided background information on the IRF; and noted that the Minister became a member of the Board of Directors in January 2017, and that Jamaica was the first Caribbean nation to be represented on the IRF Board of Directors.

The report also provided information on the areas of discussion pertinent to Jamaica, including the transformation of the road environment, the role of Big Traffic Data, and the evolution of motor vehicle technologies and the design and development of supporting road infrastructure.
