#### CABINET AGENDA ISSUES - 26 AUGUST 2019

The House is asked to note the following matters which were considered by the Cabinet at its meeting held on 26 August 2019:

#### 1. Contracts

(i) Procurement of Works for the Rose Town Integrated Infrastructure Project, St. Andrew Cabinet approved the award of a contract in the amount of \$191,468,790.40, by the Jamaica Social Investment Fund, to Contraxx Enterprises Limited to carry out rehabilitative works under the Rose Town Integrated Infrastructure Project in St. Andrew.

Integrated Infrastructure Projects are geared toward promoting public safety and community transformation through the access to and improvement of basic infrastructure and social amenities.

#### (ii) Procurement of Works for the Port Maria Fire Station Construction, St. Mary

Cabinet approved the award of a contract in the amount of \$217,507,350.00 to Marshall Construction Company Limited, by the Jamaica Social Investment Fund (JSIF), for the construction of the Port Maria Fire Station in Port Maria, St. Mary.

The construction is required as the current fire station cannot adequately serve the 46 communities in St. Mary that may call on its services.

#### (iii) Renovation of Building at 4 Sam Sharpe Square, Montego Bay, St. James

Cabinet approved the award of a contract in the amount of \$109,168,405.00 to Marshall Construction Company Limited for the renovation of the two-storey office building, which houses the National Insurance Scheme (NIS) and other services of the Ministry of Labour and Social Security, at 4 Sam Sharpe Square in Montego Bay, St. James.

The existing office plan is not conducive to the growing and diverse services provided by the Ministry of Labour and Social Security to the public.

#### (iv) Supply and Installation of Fire Suppression System at the Queens Warehouse

Cabinet approved the award of a contract in the amount of \$72,347,187.11, including General Consumption Tax, to Safety and Fire Systems Limited for the supply and installation of a fire suppression system at the Queens Warehouse.

The fire suppression system will allow for the suppression of gases as well as the extinguishing of a fire, if one occurs at the facility, which is one of the Jamaica Customs Agency's largest storage facilities for uncleared goods.

#### (v) Security Guard Services at Jamaica Customs Agency

Cabinet approved the award of a contract in the amount of \$160,142,161.70, including General Consumption Tax, to King Alarm Services Limited for security guard services at the Jamaica Customs Agency for a period of three (3) years.

The contractor will be expected to provide security services at the Jamaica Customs Agency Head Office at Newport East as well its other facilities in the Kingston Metropolitan Area.

### Acquisition of Parcels of Land for the Port Henderson Road Improvement Project, Portmore, St. Catherine

Cabinet approved the acquisition of approximately 10 parcels of land with an estimated area of take of 12,224 square metres between the Naggo Head Square and the Bayside Roundabout, which were likely to be needed for the implementation of the Port Henderson Road Improvement Project in Portmore, St. Catherine, under the Major Infrastructure Development Programme (MIDP).

The Port Henderson Road Improvement Project, which falls under the local component of the MIDP, is 1.3 kilometre in length, covers the section between the Naggo Head Square to the Bayside Roundabout, and is aimed at improving mobility and safety and reducing travelling time in Portmore and its environs.

#### 5. Approval for the National Craft Policy as a White Paper

Cabinet approved the tabling of the National Craft Policy in Houses of Parliament, as a White Paper.

The policy aims to streamline the Jamaican craft industry by facilitating incremental and significant improvements in quality, variety, value, sales, customer satisfaction and profits in order to promote greater local identity of finished craft and souvenirs.
