CABINET AGENDA ISSUES - 2 SEPTEMBER 2019

The House is asked to note the following matters which were considered by the Cabinet at its meeting held on 2 September 2019:

- 1. Contracts;
- 2. Annual Reports;
- 3. Board Appointments;

Each matter shall be elaborated on in turn.

1. Contracts

- (i) Insurance Coverage for the Jamaica Urban Transit Company Limited
 Cabinet approved the placement of general insurance for the Jamaica Urban Transit Company
 (JUTC), through Marathon Insurance Brokers Limited, for the three-year period 1 September
 2019 to 31 August 2022, with the premiums as outlined below representing the first year of the
 brokerage contract:
 - (i) placement of US\$ denominated policies US\$735,671.00; and
 - (ii) placement of J\$ denominated policies J\$20,594,698.00.

The insurance policies will serve to cover the various risk categories of the JUTC as the major government provider of public transport.

(ii) Procurement and Distribution of Primary Textbooks under the Primary Textbook Programme
Cabinet approved the award of a contract in the amount of £607,764.15 to Hodder Education
and Stoughton Limited for the procurement and distribution of Mathematics textbooks for
Grades 1 and 2 students under the Primary Textbook Programme for 2019/2020.

The Ministry of Education Youth and Information selects the best quality textbooks to be procured for use under the Primary Educational Resources Programme.

- (iii) Procurement and Distribution of Textbooks under the National Textbook Loan Scheme
 Cabinet approved the award of following contracts under the National Textbook Loan Scheme
 for 2019/2020 for the procurement and distribution of textbooks to be provided for students at
 Grades 7 to 11:
 - (i) in the amount of \$65,549,501.70 to Carlong Publishers (Caribbean) Limited; and
 - (ii) in the amount of \$145,804,035.62 to Kingston Bookshop Limited.

The National Textbook Loan Scheme provides textbooks in the major subject areas to thousands of students at the Grades 7-11 levels in High Schools and Grades 7-9 in Primary and Junior High Schools and All-Age Schools.

2. Annual Reports

Hosting of the Steering Group Meeting and Annual General Meeting of the Asset Recovery Inter-Agency Network for the Caribbean

Cabinet approved Jamaica hosting the Steering Group Meeting and Annual General Meeting of the Asset Recovery Inter-Agency Network for the Caribbean (ARIN-CARIB) during the period 18 to 20 September 2019 in Montego Bay, St. James.

The ARIN-CARIB is an informal network that cooperates on matters relating to the proceeds of crime. Jamaica currently holds the presidency of the ARIN-CARIB for the period January to December 2019 and in that capacity is expected to host the Steering Group Meeting on 18 September 2019 and the Annual General Meeting from 19 to 20 September 2019.
