#### CABINET AGENDA ISSUES - 18 NOVEMBER 2019

5. Hosting of the International Criminal Policing Organization Radiological Crime Scene

Management Course

Cabinet approved Jamaica hosting a four-day training programme, through the Ministry of National Security, in collaboration with International Criminal Policing Organization (INTERPOL), on Radiological Crime Scene Management to be held at the National Police College of Jamaica in Twickenham Park in St. Catherine, over the period 2 to 5 December

2019.

The initiative is aimed at improving the capability of personnel that are directly responsible for matters relating to security and management of Chemical, Biological, Radiological, Nuclear and High Yield Explosives (CBRNE).
