# CABINET AGENDA ISSUES - 23 MARCH 2020

# 1. Contracts

(i) Provision of Private Security Guard Services to the Firearm Licensing Authority Cabinet approved the award of a contract in the amount of \$195,752,765.61 to Quest Security Services Limited, on behalf of the Firearm Licensing Authority (FLA), for the provision of security services to the FLA for a period of three (3) years.

The placement of private security services at the three FLA locations will mitigate any threats and risks that may arise at these locations.

(ii) Procurement of Works for the Treadlight Integrated Infrastructure Project, Clarendon. Cabinet approved the award of a contract in the amount of \$149,637,624.20 to Stone Plus Limited, by the Jamaica Social Investment Fund (JSIF), to carry out rehabilitative works under the Treadlight Integrated Infrastructure Project in Clarendon.

Treadlight is a rural community located in Central Clarendon whose residents are affected by myriad infrastructural issues including, but not limited to, inadequate storm water drainage systems, deteriorated road surfaces and/or non-existent roads and inadequate water supply.
