#### 1. Contracts

# (ii) Novation Agreement Between De La Rue International Limited, ID Global Solutions Limited and the Electoral Commission of Jamaica

Cabinet approved a Novation Agreement between De La Rue International Limited, ID Global Solutions Limited and the Electoral Commission of Jamaica (ECJ) for the supply of secure identification card pre-prints to be issued to eligible electors.

The agreement has become necessary as De La Rue International Limited has sold the portion of its business that would execute the contract with the ECJ to ID Global Solutions Limited.

## 3. Sale of Land at Section 6 Pimento Terrace, Cardiff Hall Plantation, St. Ann by the Urban Development Corporation (UDC)

Cabinet approved the sale of 8.70 hectares (21.5 acres) of land registered at Volume 1055 Folio 361 of land by the Urban Development Corporation (UDC) located at section 6, Pimento Terrace, Cardiff Hall Plantation, Runaway Bay in St Ann to Mr. Rohan Miller in the amount of \$250 million for the development of residential units and amenities.

The property is a vacant residential sub-division situated on the southern side of the Ocho Rios to Montego Bay main road, and is within close proximity to a public beach and several hotels, namely: Jewels Runaway Bay, Jewels Paradise Cove and Franklyn D. Resort. The UDC has made several attempts to divest the property previously.

## 4. Extension of Scholarship Programme 2021/2022 to 2026/2027

Cabinet approved the extension of the Scholarship Programme within the Ministry of Education, Youth and Information at a cost of \$3 billion for a period of six years from 2021/2022 to 2026/2027.

Cabinet also noted that this extension would support the award of 1,230 scholarships to train additional mathematics, science (physics, biology and chemistry), technical vocational education teachers and engineers who are critically needed to meet job market demands which, once satisfied, would further drive the country's growth agenda.

Since the inception of the Scholarship Programme, the Ministry of Education, Youth and Information has offered a total of 885 mathematics and science pre-service scholarships over the five-year period spanning the 2015 to 2019 academic years, with a total of 515 mathematics, 194 science and 176 TVET scholarships having been awarded.

## Use of the National Arena as a Field Hospital for the Support of the COVID-19 Mitigation Plan

Cabinet approved the use of the National Arena as a COVID-19 Field Hospital and the associated retrofitting of the National Arena to supports its use as a COVID-19 Field Hospital.

The field hospital is intended to be a temporary hospital that will be used to provide care to COVID-19 patients on-site. The facility would be used to house patients who are COVID-19 positive patients with mild symptoms, and COVID-19 positive patients with moderate illnesses with no co-morbidities.

## 6. Impact of COVID-19 on the School Year

Cabinet approved:

- (i) the continuance of home-schooling arrangements from 22 April 2020 to end of the school year on 3 July 2020;
- (ii) the commencement of the 2020/2021 school year on 7 September 2020; and
- (iii) the pursuance of alternative arrangements for the placement of students.

These decisions were made as a result of the dislocation caused by the current COVID-19 pandemic and the challenges posed to the educational sector. The decisions also took into consideration consultations with the key stakeholders in the sector.
