Contracts

- (i) Revised Professional Fees for the New Houses of Parliament Design Project Cabinet gave approval for:
 - (i) the revised professional fees required for design consultancy for the preparation of detailed designs, statutory approvals, tendering and construction administration for the New Houses of Parliament Design Project which comprised of: the Parliament building; landscape and civil works for the National Heroes Park; other technical services; 3.5% project management fees for the Urban Development Corporation; and 5% contingency amounting to J\$1,525,096.00, including 15% General Consumption Tax or US\$10,517,904.00; and
 - (ii) the inclusion in the Supplementary Estimates for the 2020/2021 budget of J\$550,428,000.00, approximately US\$3,796,055.00, in order to finance the contractual activities for the New Houses of Parliament Design Project for this financial year.

The building will be able to accommodate 150 Members of Parliament and a separate chamber will be built to host Senate sessions. Additionally, several offices will be included in the construction of the Parliament.

4. The NCEL currently operates under the powers of the Minister of Education, Youth and Information, guided by The Education Act of 1965, but will eventually have its own legal identity under the appropriate governance arrangements for public sector entities.

5. Introduction of Premium Service Packages by the Registrar General's Department

Cabinet approved the introduction of the following premium service packages and attendant fees by the Registrar General's Department (RGD):

- (i) a same day service for the processing of Birth, Death and Marriage Certificates, where applicable;
- (ii) a next day service for the processing of Birth, Death and Marriage Certificates, where applicable; and
- (iii) the fee structures of \$7,500 for same day service; and \$6,000 for next day service, respectively.

Cabinet also approved the amendment to The Registration (Births and Deaths) (Alteration of Fees) Order, 2015 to the facilitate these services and fees.

The introduction of same day and next day service packages are a response to the request of consumers. The proposed services will be in addition to the existing express service already provided by the RGD.

6. Essential Oils Incubator Project of the Jamaica Business Development Corporation

Cabinet gave approval for the Essential Oils Incubator Project to be included in the Public Sector Investment Programme.

The Essential Oils Incubator Project would be executed by the Jamaica Business Development Corporation, which would collaborate with various partners/stakeholders in the public and private sectors, for the provision of investment, skills development, and jobs. The objectives of the project include the production of five essential oils and the creation of 6,000 jobs within four (4) years; and the potential increase in export earnings of approximately US\$500 million in the next four (4) years.

7. Hosting of the Made in Americas Global Services Summit, October 2021

Cabinet approved Jamaica hosting the Made in Americas Global Services Summit in October 2021.

The primary objective for hosting the conference is to drive new investments and positive brand awareness about the information technology enabled services sector in Jamaica. Jamaica will leverage an established event brand to the benefit of its promotional effort in the outsourcing sector.

8. Reports

(i) Quarterly Update from the National Competitiveness Council

Cabinet considered a report from the Ministry of Industry, Investment and Commerce in connection with a quarterly update from the National Competitiveness Council (NCC).

The report informed that in July 2018, the World Bank and the International Finance Corporation (IFC) presented the Jamaica Doing Business Reform (DBR) Memorandum which assessed the business environment of Jamaica within the context of global regulatory trends; and made recommendations for implementation.

The report further informed that implementation of the recommendations would move Jamaica in the position of Top 10 DBR; and the reforms had been put forward as the Business Environment Reform Agenda (BERA).

The report also informed of the implementation of a new reporting structure which would involve each implementing Ministry, department and agency reporting its progress, the next steps and interventions required for each reform on a quarterly basis; the five Technical Working Groups (TWGs) established to support the ten indicator areas of the DBR; and the Communications Subcommittee of the NCC that was activated in March 2020 to undertake a communication blitz focused on the new reform areas.

(ii) One Tablet/Laptop Per Child Initiative-Bridging the Digital Divide

Cabinet considered a report from the Ministry of Education, Youth and Information in connection with the One Tablet/Laptop per Child Initiative-Bridging the Digital Divide.

The report informed that due to the COVID-19 pandemic, schools in Jamaica were closed on 13 March 2020; approximately 600,000 students in 3,639 public and private educational institutions had been impacted; and distance learning strategies were implemented to minimise the disruption to teaching and learning during the period of school closure.

The report also informed that the Statistical Institute of Jamaica (STATIN) had estimated that 45% of families did not have access to devices or reliable Internet services; the United Nations Children's Fund (UNICEF) had posited that disruptions to instructional time in the classroom could severely impact the ability of children to learn, and the longer marginalised children were out of school, it was less likely they would return; prolonged school closures would impact students and, in some cases, cause regression academically and socially; and to mitigate these risks, the Ministry of Education, Youth and Information was taking the necessary steps to improve distance learning for this academic year.
