## The Law Reform (Zones of Special Operations) Special Security and Community Development Measures

## Social Intervention Report (as at April 8, 2021)

This Honourable House is being requested to note that after the enactment of the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) Act, the Prime Minister on the advice of the National Security Council, declared the Greenwich Town Community as the third Zone of Special Operations (ZOSO) on July 1, 2020.

The Zones of Special Operations (ZOSO) combine a robust security approach led by the Jamaica Constabulary Force (JCF) and Jamaica Defence Force (JDF), and Social Intervention Component (SIC) that coordinate and implement social development measures by the various agencies, Non-Governmental Organizations (NGOs) and the private sector.

The Social Intervention support, which was coordinated by the gazetted Social Intervention Committee saw social programmes that focused on two key strategies: Crime Prevention Through Social Development (CPTSD) and Crime Prevention Through Environmental Design (CPTED).

A key objective of the interventions and programmes was to ensure the community was reconnected to the key agencies of government that deliver each programme thus engendering sustainability and credibility among the citizen that their government is the legitimate provider of support services.

The Social Intervention Committee (SIC) is guided by SIC framework comprising of seven development areas:

- 1. Physical Environment.
- 2. Land Tenure,
- 3. Community Safety.
- 4. Human and Community Development and Employment.
- 5. Business and Economic Development.
- 6. Spiritual and Faith Based Intervention; and
- 7. Leadership.

The ZOSO is built around the approach of Clear, Hold and Build, which the latter is where long term institutions are developed within the community.

The Greenwich Town Community is in the Constituency of South West St Andrew. The community is considered urban with a population of approximately 4,400 residents and over 1,100 households.

The community has been identified as one of the most volatile and vulnerable communities in Jamaica on the Planning Institute of Jamaica (PIOJ) community renewal index. This has seen the community identified as a priority community of the GOJ Integrated Community Development project that targeted 18 high risk communities. This project is currently ongoing and will be further scaled up with the introduction of the ZOSO in the community.

The Zone will adopt the same development pillars as the other ZOSOs in Denham Town and Mount Salem. While officially a ZOSO, it should be noted that the community was part of a major urban renewal project by the Government of Jamaica that has been making significant investment in its physical infrastructure and social development. The ZOSO will see a further scale up of those activities undertaken in 2015-2019, which were principally funded by the GPJ. These include:

- 1. Road works with over 7.1km of new asphalted roadway completed in the community.
- 2. Water Improvement with 800 water laterals to allow for household connections.
- 3. Zinc fence substitution with 778 meters completed.
- 4. Livelihood interventions including summer programmes and skills training benefitting over 80 youths in the community.
- 5. Rehabilitation of the St Andrew Primary school which supports the community.
- 6. Entrepreneurial support for businesses in the community
- 7. Provision of civil documentation to over 300 residents.

## **UPDATE** - February 5, 2021 - April 8, 2021

Social Intervention Committee: There were no full meetings of the SIC committee during
the review period. The development activities however which have been developed by the
SIC continued to guide the overall development and implementation of activities in the zone.

- 2. Enterprise Grant (Training of entrepreneurs). Twenty-Five (25) micro entrepreneurs, who accessed over J\$2M in equipment grants, commenced online training in business development. This is aimed at developing their capacity and forms part of the overall sustainability of the intervention. A further J\$5million, will be procured to provide additional support to the fisher folks during the next three months.
- 3. School Rehabilitation The formulation activities for the proposed activity remains at an advanced stage of formulation, however delays associated with the COVID-19 has affected overall completion, but the projections remain for implementation within Q1 of financial year 2021, at a cost of the project of approximately \$1.1 Million.
- 4. Environmental Wardens The twenty-five (25) wardens remain actively engaged and are supporting the work of the NSWMA within the community. They do both cleanup activities, as well as information dissemination to the community around effective sanitation.
