CABINET AGENDA ISSUES - 27 SEPTEMBER 2021

The House is asked to note the following matters which were considered by the Cabinet at its meeting held on 27 September 2021:

1. Contracts

(i) Port Royal Potable Water Transmission Main Upgrade

Cabinet approved the award of a contract in the amount of \$312,472,713.66 to Ashtrom Building Systems Limited, for the Port Royal transmission main upgrade.

The transmission main, which is required to support the capital investments already made in Port Roya,I is inefficient and unreliable and has to be replaced urgently. The scope of work includes the supply and installation of 8,600m of 315mm (12") diameter HDPE pipes together with various air and wash out valves.

(ii) Follow-On Contract for the Procurement of Motor Vehicle Consumables

Cabinet approved the award of a contract in the amount of US\$598,500.00 or J\$92,790,990.00 to HID CID Limited, for the provision of motor vehicle consumables for a period of one (1) year, 2021 to 2022.

The scope of work includes the provision of 150,000 teslin driving licence cards; 150,000 driver's licence laminates; 750,000 motor vehicle registration certificates; 750,000 motor vehicle registration stickers; and 100,000 motor vehicle certificates of title.

(iii) Renovation of Restrooms at the Jamaica Conference Centre

Cabinet approved the award of a contract in the amount of \$115,088,755.00 to Geecho Consultants & Construction Limited, to undertake renovation works on the restrooms at the Jamaica Conference Centre located at 14 to 20 Port Royal Street, Kingston.

The scope of work includes, but is not limited to, demolition and site clearance as necessary, installation of tiles, doors, partitions, ceilings, vanity counters, sanitary fixtures, wall finishes, as well as glazing and painting, plumbing and electrical infrastructure as specified.

(iv) Supply of Clinical Chemistry Systems for General Chemistry and Immunochemistry to the Cornwall Regional Hospital

Cabinet approved the award of a contract in the amount of US\$2,229,521.23 to Facey Commodity Limited, for the supply of clinical systems for general chemical and immunochemistry for the Comwall Regional Hospital (CRH) for a period of three (3) years.

The Western Regional Health Authority (WRHA) utilizes chemistry reagents in the conducting of a range of screening and diagnostic testing in the delivery of services at the Cornwall Regional Hospital. Such testing is applicable to identifying conditions such as diabetes and hyperthyroidism during clinical diagnosis and as part of regular health check-ups.

- 4. National Housing Trust Special Benefit Order Hummingbird Meadows, Phase 1, Housing Development, Clarendon

Cabinet approved the promulgation of a Special Benefit Order, effective 30 July 2021 to facilitate the allocation of sixteen (13) housing solutions at the Hummingbird Meadows, Phase 1, Housing Development in Clarendon, to contributors to the National Housing Trust who meet the specified criteria; and the issuance of drafting instructions to the Chief Parliamentary Counsel to facilitate the promulgation of the said Special Benefit Orders:

The Special Benefit Order will facilitate the allocation of 16 housing solutions to varying numbers of persons representing contributors from the Jamaica Constabulary Force, Jamaica Defence Force, Jamaica Teachers' Association, Nurses Association of Jamaica, Jamaica Civil Service Association, and the Jamaica Confederation of Trade Unions.
