The following day she made a report to Constable *** at Linstead police Station and he issued her with a receipt and letter to seek medical attention. She went to the Linstead Hospital where she was examined, x-rayed and treated.	The file is closed as the complainant is unwilling to proceed with the matter. 3	Conduct Unbecoming	NC	The complainant NC states that on January 16, 2022 police officers from the Old Harbour Police Station came to his home and pointed a firearm through his window. The police then ordered him to open his door to which he states that he complied. NC reports that the officers entered the home and searched him and his 15 year old cousin. NC states that he asked the officer what they were doing there and he was told that someone in a taxi he travelled in reported their phone stolen and gave his description as the suspect. NC states that he told the officers he is not a thief. He reports that the officers began to search the house and he kept asking "where is the phone?" NC states that he began to feel fearful, took out his phone and began to call his mother. He reports that one of the officers then hit him in his chest and said "yuh nuh know yuh will dead in yah?" NC states that he kept telling the officers that he did not take any phone. He was subsequently taken to the Old Harbour Police Station where he was heldabouts is still unknown. 4	Threat	RL	On Friday, September 28, 2021, RL made a complaint to INDECOM reporting that whilst on his way home he was pulled over by three (3) Police Officers. He states that during his interaction with the police officers, he was threatened by two of them. He says this is a result of where he pulled over as he drove down closer to them so he could see around the corner. He states that the officers said to him he should have pulled over where they told him to pull over. He explained why he did what he did but the second officer threatened to shoot into his car. After the incident, the police went to RL's house and attempted to prise off the grill whilst he was not there. He knew this because he has a camera system in his house and he was monitoring it from his phone. He states that they went back to his house on September 27, 2021 and again attempted to prise off his grill.	The file is closed as the complainant is unwilling to proceed with the matter. It is hereby recommended that no criminal charges be laid or disciplinary action taken in respect of this complaint.	No Charge
5	Assault	SS	The complainant SS reports that on Wednesday, September 22, 2021 at approximately 8:45 p.m. she was assaulted by a police officer known to her as Officer *** in front of her shop at Church Gate, Mavis Bank, St. Andrew. SS said that she was in the yard where the shop is located with friends when she saw a police vehicle passing with her cousin (an officer) accompanied her husband officer ***. She went up to the vehicle and told the officer that she was keeping a get together for her birthday. Before Officer *** left he instructed SS to close her shop and turn down the music. She complied but upon Officer ***'s return he stopped the vehicle and dragged/pushed SS out of a crowd into the police vehicle. SS said she got angry and cursed Officer *** telling him that he was unfair as just the previous Saturday she saw him using the government vehicle to transport water and cake for a cake sale that was put on by his niece-in-law. SS received injuries to right arm, right shoulder and knees when Officer *** attempted to place her in the police vehicle.	The file is closed as the complainant is unwilling to proceed with the matter. It is hereby recommended that no criminal charges be laid or disciplinary action taken in respect of this complaint. 6	Fatality	Brianna Kerr Derrick Coley	On Friday, December 3, 2021 about 1:50 a.m. a traffic collision occurred along Mountain View Avenue at the foot bridge in the vicinity of Deanery Avenue junction involving a motorcycle driven by Derrick Coley, 40 years old, D.O.B. 11.09.1981 of Glasspole Avenue, Rockfort, Kingston 2 with pillion Brianna Kerr, 24 yrs. old D.O.B. 02.12.1997 unemployed of Windward Way, Kingston 2 resulting in their deaths. Investigations revealed that the motorcycle was travelling in a southerly direction along Mountain View Avenue when on reaching the vicinity of Deanery Avenue the driver lost control and the motor cycle went on the foot bridge and overturned. The driver and pillion were thrown on the concrete path of the bridge and sustained multiple injuries. They were rushed to the Kingston Public Hospital where Brianna Kerr was pronounced dead by Doctor at 2:45 a.m. and Derrick Coley died at 8:25 a.m. while undergoing surgery. He was pronounced dead by Doctor. The motorcycle was removed by unknown assailants and its whereabouts is still unknown. Family members of both deceased persons were contacted and they are alleging that the motorcycle was hit by a police vehicle that was chasing it. There are no independent eye witness(es) to this fatal incident. CCTV Footages were obtain from premises Mountain View Avenue, the footages did not add any value to the investigation. There is no evidence to substantiate the allegations that Ms. Kerr and Mr. Coley came to their deaths at the hands of the police	The Commission respectfully recommends that: a) No criminal charges be laid or disciplinary action be taken against any member of the Jamaica Constabulary Force, in relation to the fatality of Brianna Kerr and Derrick Coley. b) The file to be closed. 7	Death of Custody	Larkland Bryan	On March 29, 1974, Mr. Larkland Bryan was admitted to Tower Street Adult Correctional Center, after he was tried for murder and found guilty for the offence of manslaughter on the grounds of diminished responsibility in the Clarendon Circuit Court. Inmate Larkland Bryan died on October 26, 2021, at the Kingston Public Hospital where he was a patient. The cause of death was stated as persistent diarrhea with recent history of COVID-19 infection. There is no evidence to indicate that there was any negligence on the part of the concerned officers.	The Commission respectfully recommends that: a) No criminal charges be laid or disciplinary action be taken against any member of the Department of Correctional Services Department in relation to death of Larkland Bryan. b) The file be forwarded to the Special Coroner. 8	Death of Custody	Barrington White	Convicted Inmate Barrington White, Registration number #01-20-0108 of the Tower Street Adult Correctional Centre (TSACC) was diagnosed with Covid 19. He subsequently succumbed to his ailments at the Kingston Public Hospital (KPH). Mr. Barrington White was pronounced dead by Doctor at the Kingston Public Hospital (K.P.H) on Friday, September 24, 2021, about 4:55 p.m. The cause of death was stated as Covid-19 pneumonia, Human Immunodeficiency Virus (HIV) infection and asthma. There is no evidence to indicate that there was any negligence on the part of the concerned officers. 	Shooting Injury	MM	Superintendent *** split the team and assigned different officers to various cordons to cut off possible escape routes. Six officers from the operation were sent to 3 rd Avenue armed with a warrant for guns and drugs. Upon reaching the premises at no.14 3 rd Avenue, the police officers alighted from their unmarked vehicle and entered the yard. Upon entering the premises the officers reported that they heard gun fire coming from different directions. Four of the officers made their way to the back of the premises while two officers remained at the front. The two officers at the front reported seeing 8-9 armed men walking down 3 rd Avenue towards their position. The officers identified themselves and the men opened fire. The two officers at the front returned fire. The officers called for support. After the fire fight subsided and support arrived the officers made their way out to the street where they saw an injured man about 60 meters from their position. The injured man was clutching a firearm. The officers held their position until day break when they again broke off into different groups to comb the rest of the neighborhood. During this sweep blood stains lead the officers through a yard where another man was found lying injured near a gully with a gun containing 8 live rounds and 16 other rounds in a sock in his pocket. A man turned up at the Kingston Public Hospital suffering from gunshot injuries in relation to the shooting incident that occurred in the Mountain View Area. 10	Fatal Shooting	Unidentified Man	On the January 23, 2013 about 10:50 p.m. Constables of the Greater Portmore Police station were on mobile patrol in the Portmore Police area when they received an assignment regarding a break-in in progress. On their way to the location three men were seen acting in a way which aroused their suspicion. Cons. *** who was driving stopped the vehicle, alighted and rushed towards the men and shouted police. The men pulled firearms and opened fire at the police. Cons. *** reported that he threw himself to the ground and returned the fire. One of the men fell and the other two ran into a gully. The other members of the patrol also fired at the men. When the firing ceased he approached the man lying on the ground and saw a firearm and observed that he was suffering from gunshot wounds. He picked up the gun and examined it and found that it was a Glock pistol. The injured man was taken to the Spanish Town Hospital where he was pronounced dead on arrival.	The Commission respectfully recommends that: a) No criminal charges be laid or disciplinary action be taken in relation to the fatal shooting of an unidentified male. b) The file be forwarded to the Special Coroner. 11	Assault	JP	The complainant, JP reported that on July 12, 2020, he and his girlfriend LM attended an illegal car show in Iron shore, Montego Bay, St. James. Whilst there, police and soldiers showed up and they decided to leave. In an attempt to leave the area, JP said he and 'L' got into his Silver 2013 Subaru Imprezza motorcar and drove off. Upon reaching the intersection to exit on to the Iron shore main road he collided with a JDF Lorry registered 10JDF393. At this point, JP alleged that the soldiers alighted from the lorry and surrounded his car. He further stated that one of the soldiers then came over to his side of the car, draped him, and pushed him against the car. He explained that at this time he felt fearful for his life and his girlfriend came and asked the soldier to let go of him. Thereafter, JP said the soldiers search the vehicle and found nothing. They then took his car documents and await police control to arrive. When police control arrived he told them what happened and said he would take full responsibility to fix his car. 12	Assault	DM	The complainant DM alleges that he was assaulted by officers at his home and at the Savanna-lamar Police Station.	It is hereby recommended that no criminal charges be laid or disciplinary action taken in respect of this complaint.	No Charge
13	Neglect of Duty	EW	The complainant EW, the mother of RD o/c Papa stated that her son was mobbed and killed by residents of Pentecost Lane, Darliston, Westmoreland on March 4, 2020. The complainant said that she was informed that police officers who were present at the time of the mobbing allowed the residents to kill her son. 14	Assault	TD	The complainant, TD is alleging that she was assaulted by Constable *** on the 1 st day of June 2017. She claims that while at K & G Bar, she was in the process of preparing a 'spliff' and was approached by an officer who became irate when she told him that he could not lock her up for marijuana. He allegedly pushed her out the said bar and kicked her feet causing her to fall and then aggressively held on to her. She also states that he was in the company of another officer who did nothing to assist her and later discovered his name to be Constable ***. Having investigated the matter, the Commission finds no prima facie case to be in existence. The words of threat allegedly uttered by the concerned officer were, "Well if yuh naah open the door we caan guarantee your safety after today" after the said complainant refused to open the door for failing to produce a search warrant. Having investigated the matter, the Commission finds no prima facie case to be in existence.	The Commission hereby recommends that no criminal charges be laid nor disciplinary action be taken. 16	Assault	GW	The complainant, GW is alleging that he was assaulted by Constable *** while in custody at the Yallahs Police Station on the 15 th day of June 2017. No medical report has been obtained herein and no police officer has been properly identified as being involved in the alleged assault on the complainant. Having investigated the matter, the Commission finds no prima facie case to be in existence. He further alleges that the said officer threatened to kill him and states that he was previously threatened by the same officer sometime in 2016. Having investigated the matter, the Commission finds no prima facie case to be in existence.	The Commission hereby recommends that no criminal charges be laid nor disciplinary action be taken regarding this complaint.	No Charge
20	Assault	AR	The complainant, AR is alleging that he was assaulted by Constable ** and Constable *** on the 28 th day of June 2017. He claims that the officer stepped on his legs causing bruising to his left foot and then kicked him on his penis causing him pain. He also states that the said officer pepper sprayed him in his eyes, face and chest causing a burning sensation to those areas. Having investigated the matter, the Commission finds no prima facie case to be in existence.	The Commission hereby recommends that no criminal charges be laid nor disciplinary action be taken regarding this complaint.	No Charge
21	Assault	MP	The complainant, MP alleges that he was assaulted by Constable ***, and District Constable ***, on the instructions of Sergeant ***, on the 18 th day of May, 2017. He claims that he was beaten with a board, causing him to sustain injuries to his both his legs. Given the complainant's lack of interest in pursuing this matter, the Commission recommends that this file be closed.	The Commission hereby recommends that no criminal charges be laid nor disciplinary action be taken regarding this complaint, at this time. It is open to the complainant to peruse his civil remedies. 22	Assault	AB	On a date in December 2016, the complainant, AB states he was in his cell at the Morant Bay Police Station lock-up when a dispute began between him and his fellow prisoner. Following this incident, two (2) police officers entered his cell to quell the dispute and one of these officers used a baton to hit AB on his left hand causing swelling.	The Commission respectfully recommends that no criminal charges be laid, or disciplinary action be taken against any member of the Jamaica Constabulary Force and the file closed.	No Charge
23	Assault	KB	On Sunday, December 18, 2016 the complainant KB and her family were travelling in the community of Montego Bay, St. James along the West Gate Main Road when their vehicle was stopped by the police. The documents for the vehicle were requested and her father supplied them to the police. The police made enquires as to why he had submitted a foreign driver's licence, and not a Jamaican licence, however, despite this, the documents were returned and they were advised they could go. While attempting to leave the area, the vehicle they were in, a blue pick-up van developed difficulties and they came out to push the vehicle. While pushing the said police officers began to verbally abuse the complainant and her sister and cursed at them. The complainant challenged the officers and a dispute ensued. One of the officers then kicked her and she retaliated by grabbing him in his chest causing his Ballistic vest to open, and then she kicked him. She was grabbed and her hands forced behind her by another officer, and then the police who kicked her then slapped her in her face and sprayed pepper spray on her causing the left side of her face and her left shoulder to burn. She was eventually released by the officer who held on to her and she returned to the pick-up with her family, and they left the scene.	The Commission respectfully recommends that: a) No criminal charges be laid, or disciplinary action be taken Constable be exposed to retraining in the use of non-lethal force and effective communication with civilians, and the file closed. 24	Assault	DG	On Tuesday, January 3, 2017, the complainant, DG was inside his cell at the Falmouth Police Station lock-up where he was housed, when a team of police entered the cell and requested a search of the cell. Whilst doing so DG was stooped in an area of the cell and was grabbed by one of the officers, resulting in him falling and hitting the back of his head on the floor. As DG turned to get up off the ground he then felt several hits to his body from a baton and saw the team of police hitting him all over his body. DG managed to get away from the officers and enquired of them what he did to receive the beating and one of the officers threatened to 'obeah' him when he is released. DG was then returned to his cell and was not given any medical attention. The police report that on the day in question at about 5pm they proceeded to conduct the mandatory search of the cells. They prisoners were alerted to the search and the cells opened to facilitate the search. Upon arriving at cell four, the men were instructed to exit the cell, however DG refused to exit the cell. DG became boisterous towards Cpl ***, and refused to be searched. When DG was held by the police he used his hand to slap the officer in his face and became even more boisterous, and attacked the officer who used his baton to defend himself, and to subdue DG. At this point the cellmates of DG became aggressive and were restrained by other officers. The cell was searched and the prisoners then returned to their cells, and the search of the cells was subsequently concluded.	The Commission respectfully recommends that no criminal charges be laid, or disciplinary action be taken and the file be closed.	No Charge
25	Shooting Injury	AR JD	On Friday, July 15, 2011 the complainants were at SR's home in Old Harbour, St. Catherine when Detective Special Corporal entered the house. Det Spl Cpl was the boyfriend of SR, and when he entered he sat inside the living room and had conversation with SR and her son J. Whilst the occupants of the house to include the complainants and SR were seated in the living room watching television, they heard a loud explosion that sounded like a gunshot. Det Spl Cpl was then seen rushing outside with his firearm drawn and subsequently returned. Following the loud explosion, it was discovered that the complainants, who are both minors were injured and bleeding. The complainants were rushed to the Spanish Town Hospital where it was discovered that they had been injured by gunshot. The minors were treated and admitted, and a report was later made to the police concerning the incident.	The Commission hereby recommended that no criminal charges be laid, or disciplinary action be taken and that the file be closed.	No Charge
26	Shooting Injury	FD	The complainant FD was a patron at a birthday party for his friend D being held on Seacole Avenue in St. Andrew, on Tuesday, January 12, 2021. While there enjoying the party he was handed a handgun by his friend to hold whilst his friend visited the restroom. He saw a police vehicle drive up to the location, and approached almost simultaneously. Upon seeing the police he walked off from the area and headed towards Spanish Town Road. The police shouted to him, but he continued walking and then began to run towards Spanish Town Road when they opened fire at him. Whilst running his foot went into a hole, and he then fell to the ground and the firearm he had placed in the front of his waistband, fell to the ground. As he became frightened during the shooting, he continued to run until he got to the yard of a friend of his, where he sought refuge. The police eventually came to the house he entered and he was accosted. It was at that point that he realised he had been shot and injured. He was subsequently escorted the police who kicked her then slapped her in her face and sprayed pepper spray on her causing the left side of her face and her left shoulder to burn. She was eventually released by the officer who held o	It is hereby recommended that no criminal charges be laid, or disciplinary action be taken and that the file be closed.	No Charge

27	Assault	EG	On Monday, December 19, 2016 the complainant, EG was on his way to Kingston in his motorcar when he was stopped by the police along the Winston Jones Highway, and he complied. He was asked if he had anything to declare and advised them that he had a licensed firearm. He was instructed to exit the car so that it could be searched, and he enquired the reason for him to exit the vehicle. Following this discussion, he was not adequately advised of the reason, and he refused to exit his vehicle. He was then approached by another officer who was towards the rear of the car who told him to get out of the car. EG was then slapped to his face by this officer and being in shock ran to the back of his vehicle. He was then grabbed by his shirt from behind and pulled backwards resulting in his shirt being torn. Following an exchange of words between the officer and himself, EG was handcuffed and subsequently slapped in the face five (5) times by the said officer. EG was then placed inside the service vehicle and later relthe police who kicked her then slapped her in her face and sprayed pepper spray on her causing the left side of her face and her left shoulder to burn. 28	Assault	AM	The complainant, AM was a patron at the ‘Royal Street Tavern’ on December 17, 2016 when about sometime between 1am and 3am he was dragged out of the bar by someone he recognised to be a soldier, dressed in army fatigue. He was slapped several times to his face by the soldier who then pushed him into a zinc fence causing him to experience pain in his face and chest area. AM was subjected to several hits by persons whom he identified as police officers and soldiers based on their attire, and was kicked several times whilst lying face down on the ground. AM was threatened by the members of the security forces, and subsequently humiliated by having a soldier force his rifle into his mouth and pushing it back and forth to encourage a sucking motion. AM was released after enduring a beating and humiliation, and was later assisted to the hospital and was admitted to the Cornwall Regional Hospital where he was treated, admitted and later released. The members of the Jamaica Defence Force (JDF) who were on a joint police-military operation report that on the morning of the day in question, they were tasked with operating a cordon around a building said to be housing a party whereby person of interest YJ o/c ‘Fry Eye’ would be present. The operation resulted in the apprehension of one known as ‘D’ said to be an associate of YJ. The soldiers report that several persons were detained by the police who conducted screening of the patrons and facilitated the transfer of the detainees to the Lucea Police Station. They reported that two men were apprehended at a nearby premises after the security forces were directed to a house, and following them hearing a gunshot coming from that direction. The soldiers who were a part of the operation reported that some men were seen to the left side of the road and enquires made as to how one of the men received bruises to his face, this man related being unable to say whether police officers or soldiers assaulted him due to his state of intoxication.	The Commission respectfully recommends that no criminal charges be laid, or disciplinary action be taken relative to this complaint, and the file closed.	No Charge
29	Unlawful Wounding	TH	The complainant, TH was walking on the sidewalk along Nampriel Main Road in Negril, Westmoreland on Saturday, January 6, 2018 when he saw a motorcar speed past him along the road, and followed shortly thereafter by a police officer on a motorcycle. TH was struck down by the policeman’s motorcycle as the motorcycle came on to the sidewalk as it pursued the speeding motorcar. The policeman who struck him with his motorcycle did not stop but continued along in his pursuit of the speeding motorcar. Shortly after this, he was assisted to the Negril Fire Station compound by some bike taxi men who were in the area. At the Fire Station he was treated by one of the firemen and was advised to visit the hospital. While at the fire station the policeman he saw on the motorcycle who hit him down came on the compound and told him he was unaware that he had been hit. This policeman then handed him one thousand dollars (\$1000.00) and told him to use it to get to the hospital for treatment. He visited the hospital on January the police who kicked her then slapped her in her face and sprayed pepper spray on her causing the left side of her face and her left shoulder to burn. 30	Assault	DC	A letter dated March 13, 2014, from the Commissioner of the Department of Corrections was received by the Commission. Said report evinced that on Friday, February 7, 2014, <i>Woman Overseer</i> who was on duty at the Fort Augusta Adult Correctional Center, was conducting a routine check of dormitory #5 when she observed the complainant and inmate, DC, using a cellular phone. W/Ovsr. made an attempt to retrieve the phone from the complainant who subsequently bit her on the lower part of her right hand.	The Commission hereby recommends that no criminal charges be laid or disciplinary action be pursued against any member of the Security Forces in respect of the instant complaint.	No Charge
