PART ONE: NEW COMPLAINTS

For the period, January to March 2022, the Commission received 316 categories of complaints from 259 incidents reported for the period. The top five categories of complaints include: assault (101), discharge of firearm (57), fatal shooting (28)* [see page 5], unprofessional conduct (24) and threat (19).

The Commission's Forensic Unit responded to 69 incident scenes during the period, January to March 2022. There were eight deaths in custody for the period.

Incident reports were received for all parishes, with Kingston and St. Andrew recording the highest with 101 complaints. Portland recorded the least with four (4) reports.

PART TWO: THE LEGAL DEPARTMENT

In the Legal Department, 199 Commission's Reports were distributed and completed during the first quarter, January to March 2022. An overview of the reports completed, lists the recommendations for no charge, disciplinary action or charge. Recommendations from fatal shooting incidents, where Commission's Reports were completed as well as rulings by the Office of the Director of Public Prosecutions (ODPP) during the quarter are also listed. One (1) member of the Jamaica Constabulary Force (JCF) was charged during the period, for an incident investigated by INDECOM.


PART THREE: PUBLIC INFORMATION


NEW COMPLAINTS: JANUARY - MARCH 2022

- * Assault includes assault occasioning bodily harm and assault at common law


Graph 1 shows the 316 categories for the 259 new incidents for which complaints were received by the Commission during the period January to March 2022

COMPLAINTS BY PARISH




Graph 3 shows the breakdown per parish for the 259 new complaints received by the Commission during the period January to March 2022



COMMISSION'S REPORTS RECOMMENDATIONS – FATAL SHOOTING INCIDENTS

No.	Date of Incident	Victim	Case Summary	INDECOM
1.	May 18, 2012	Marlon Hanson	On Friday, May 18, 2012 a party of police personnel assigned to the May Pen OST led by Corporal and three other officers were responding to information received that men armed with guns were seen in the Effortville area firing shots and threatening to set houses on fire. The action of these men is said to be in retaliation for the murder of a Merrick Richards which occurred in the area on May 17, 2012. The police team travelled in two units namely, OST 1 and 2. It is further reported that on their arrival in the area, three men were seen. They were all armed with guns and on the approach of the police; the men opened fire and ran. The police pursued them and on reaching the top of the hill, they received signal that two of the men went into a house nearby. The police headed towards a house and reportedly saw two men coming from the back door. It is alleged that one of the men opened fire on Corporal. He returned fire and the man was hit, the other man ran to a board house nearby. The man who was shot by Corporal reportedly fell to a corner of the house and a 1.38 ROSI revolver serial #M51730 containing three live rounds and three spent shells were allegedly taken from him. He was taken to the May Pen Hospital where he was pronounced dead. The man was identified as Marlon	Recommendations No Charge
2.	January 23, 2013	Unidentified Man	Hanson. On January 23, 2013 about 10:50 p.m. Constables of the Greater Portmore Police station were on mobile patrol in the Portmore Police area when they received an assignment regarding a break-in in progress. On their way to the location three men were seen acting in a way which aroused their suspicion. Cons. *** who was driving stopped the vehicle, alighted and rushed towards the men and shouted police. The men pulled firearms and opened fire at the police. Cons. *** reported that he threw himself to the ground and returned the fire. One of the men fell and the other two ran into a gully. The other members of the patrol also fired at the men. When the firing ceased he approached the man lying on the ground and saw a firearm and observed that he was suffering from gunshot wounds. He picked up the gun and examined it and found that it was a Glock pistol. The injured man was taken to the Spanish Town Hospital where he was pronounced dead on arrival.	No Charge
3.	April 9, 2015	Jermaine Brown	On Thursday, April 9, 2015 at about 12:05 p.m. Constables of the Old Harbour Police Station were travelling in an unmarked police car behind a public passenger minibus along the Old Harbour Main Road when the bus stopped in the vicinity of McCooks Gardens. A female passenger exited the bus and alerted the police officers of a robbery in progress and pointed out two men to officers. The men ran along a dirt road known as 'Bottom Lane' and the police gave chase. On reaching the end of Bottom Lane, the men opened gunfire at the police who returned the fire and a shoot-out ensued. One man was hit and the other escaped. A 9mm pistol with 9 live rounds was recovered from the injured man. The injured man was taken to Spanish Town Hospital where he was pronounced dead on arrival. The deceased man who was unidentified at the time, was searched by the police and three cellular phones, a wallet and a gold bracelet were found in his	No Charge

July 25, 2015	Omar Fletcher	On Saturday, July 25, 2015 at about 7:33 p.m. a police party was dispatched on patrol in the Seaforth area in service vehicle C043 when they received information of a man wearing a yellow shirt armed with a firearm. The police party proceeded and went on foot when they saw man fitting the description given and leading a donkey, upon seeing the police the man pulled a firearm and opened fire at the party who took evasive action and returned fire when the man ran off and fell. After the shooting subsided the man was seen suffering from gunshot wounds and one (1) Taurus pistol serial number obscured loaded with twelve (12) 9mm cartridges found beside him. He was rushed to the Princess Margaret Hospital and was pronounced dead by Dr. B.	No Charge
5.	September 24, 2015	Chadrick Morgan and Anthony Grant	Police reported that they received reports of men armed with guns at a party in the Mountain View area of Kingston. An operation was mounted using police personnel from Kingston Central and Mobile Reserve. Upon reaching the target area the team which led on the ground by Superintendent *** split the team and assigned different officers to various cordons to cut off possible escape routes. Six officers from the operation were sent to 3rd Avenue armed with a warrant for guns and drugs. Upon reaching the premises at no.14 3rd Avenue, the police officers alighted from their unmarked vehicle and entered the yard. Upon entering the premises the officers reported that they heard gun fire coming from different directions. Four of the officers made their way to the back of the premises while two officers remained at the front. The two officers at the front reported seeing 8-9 armed men walking down 3rd Avenue towards their position. The officers identified themselves and the men opened fire. The two officers at the front returned fire. The officers called for support. After the fire fight subsided and support arrived the officers made their way out to the street where they saw an injured man about 60 meters from their position. The injured man was clutching a firearm. The officers held their position until day break when they again broke off into different groups to comb the rest of the neighborhood. During this sweep blood stains lead the officers through a yard where another man was found lying injured near a gully with a gun containing 8 live rounds and 16 other rounds in a sock in his pocket. A man turned up at the Kingston Public Hospital suffering from gunshot injuries in relation to the shooting incident that occurred in the Mountain View Area. This man was interviewed and a statement recorded from him.	No Charge
6.	February 28, 2017	Eric Whittingham	Interviewed and a statement recorded from him. On February 28, 2017 a joint police/military team was on patrol duties in the hot spots of the Clarendon Division when they received information that armed men were hiding in a house at Treadlight District. Acting on the information allegations are that about 6:25 a.m., members of the police team went to an unfinished dwelling house, three (3) police officers went to right side of the house, while others went to the left. The officers that went to the right encountered three (3) men who engaged them in a shootout. The gun fire was returned and the men fled in different directions in bushes behind the house. After the shooting one man was found suffering from gunshot wounds. Information coming to INDECOM is that the deceased was known by the police as he is frequently arrested for theft and other minor offenses, also that he may be of unsound mind. Accordingly, the Commission has recommended	No Charge

that no criminal charges be pursued at this time, and that the matter be forwarded to the Special Coroner for him to decide whether an inquest will be held. January 2, 2018 **Brandon Campbell** On Tuesday, January 2, 2018 at about 7:50 a.m. a team No Charge 7. of police officers were on Flag March and inquiries in St Andrew South when information was received that a group of men were seen with high powered firearms at Crescent Road, Kingston 13. When the police arrived on the scene they were greeted with gunfire. The police returned the fire and a man was found suffering from what appeared to be gunshot wounds. His driver's license revealed that he is Brandon Campbell. He was rushed to the Kingston Public Hospital where he was pronounced dead. On Thursday, June 14, 2018 at about 12:40 a.m. June 14, 2018 Garfield McToggart No Charge Constables were on patrol in a marked service vehicle with registration FO28 along Drax Hall main road, St. Ann. It is alleged that the officers heard a transmission over the radio from the Highway Patrol unit, with registration number F0031, in relation to a vehicle that refused to stop. The officers responded and upon reaching close to the roundabout in the vicinity of the Marcus Gravey High School, they noticed that the aforementioned vehicle was stopped by an OST unit. A grey Nissan Note with registration 1276GX which was travelling behind the car the OST unit had stopped sped off. Constables chased the grey Nissan Note in the marked service vehicle. Upon reaching the Boot Gas Station, the police team heard loud explosions coming from the direction of the Nissan Note motorcar. They also heard additional explosions when the said grey Nissan motorcar reached the gate of Jewel's hotel. The grey Nissan Note drove around the roundabout in Mammee Bay and into the Greenwich Acres Housing Scheme. The police officers heard more explosions coming from the direction of the said motorcar and Constable discharged two (2) rounds from his Glock service pistol into the air. The grey Nissan Note then travelled into the Steer Town community where it ran off the road and crashed in a gully. Two men ran from the grey Nissan Note and fired in the direction of the police. Constables returned fire in the direction of the men. One man escaped and one man was seen with body partially in the vehicle suffering from gunshot wounds and clutching a Smith & Wesson 9mm pistol bearing serial number A842453. He was rushed to the St. Ann's Bay Hospital where he was pronounced dead. A man identified as DB was found by the police in Drax Hall, St. Ann suffering from a gunshot wound to his right thigh. He was taken to the St. Ann's Bay Public Hospital for treatment. October 10, 2018 Stacy Robinson The deceased, Stacy Robinson was shot by her No Charge husband, District Constable on October 10, 2018 in circumstances which were allegedly accidental. The Commission's investigation yielded no witness to the incident which gave evidence contrary to or inconsistent with the allegations made by the concerned officer. Having examined the evidence and found that it is unlikely that a jury would convict the concerned officer of any offence, the Commission recommends that no criminal charges be laid nor disciplinary action be taken. 10. January 8, 2019 Tevin Headley On Tuesday, January 8, 2019 at 2:00 p.m. a police team No Charge from the Kingston Eastern Division was on patrol when they received information that gunmen were at #11 Norman Avenue. They sought the assistance of other unit, went to the address and surrounded the premises, knocked on the door and shouted "Police". No response

was received but shuffling was heard inside the premises. The team that was at the back of the premises saw a man exiting the back door with a firearm in his hand. The man fired one round in the direction of the team and a member of the team returned fire. Shortly thereafter two other men and a woman exited the house through the same door. The female threw herself at the man on the ground and the two (2) men started to behave boisterously along with the female at which time the police had to use the pepper spray to restrain them. 11. May 29, 2020 Kemoy Crooks On May 29, 2020, the deceased, Kemoy Crooks, was Charge as per DPP Ruling on February 28, shot and killed in Whitehall, Negril in Westmoreland during an incident involving concerned officer, 2022 Constable of the Negril Police Station. After the deceased and other men fled on the approach of a police service unit, Constable and his colleague, Corporal gave chase to the fleeing men in different directions. Whilst the deceased and another man had hold of a chain link fence with both their hands with the intent to climb over the same, Constable fired a single round in their direction after which the deceased fell from the fence. The deceased ultimately succumbed to a gunshot injury to the front region of his neck. There was no firearm recovered from the incident scene postincident. 12. December 20, 2020 **Andrew Chambers** On Sunday, December 20, 2020 the police received No Charae

information that armed men were at a shop in the community of Greenvale. The officers after waiting on additional support went to the location and observed one of the men passing an object to another, upon seeing the police the man ran. One of the men had a bulge in his waist; the officer went to prevent the man from reaching for the bulge. The man then wrestled the officer's M16 Rifle out of his hand, the officer then grabbed the assailant pulled his secondary weapon and discharge two rounds causing injury to himself and the victim. The victim was taken to the hospital where he was pronounced dead. There are no independent
