The officers he said asked him for the key to his room and after telling them he didn't have it, he was boxed, kicked and pepper sprayed by officers unknown to him from the May Pen Police Station. As a result of the assault, he received cuts, bruises and a bloody nose. He was taken to the May Pen Hospital where he was treated and released into the custody of the police.
