IN THIS EDITION OF THE IQ

PART ONE: NEW COMPLAINTS

For the period, April to June 2022, the Commission received 304 categories of complaints from 241 incidents reported for the period. The top five categories of complaints include: assault (96), discharge of firearm (61), shooting injury (23), unprofessional conduct (20) and fatal shooting (18)* [see page 5].

The Commission's Forensic Unit responded to 95 incident scenes during the period, April to June 2022. There were six deaths in custody for the period.

Incident reports were received for all but one parish, with Kingston and St. Andrew recording the highest with 86 complaints. No complaints were received for Portland for the period.

PART TWO: THE LEGAL DEPARTMENT

In the Legal Department, 234 Commission's Reports were completed and distributed during the second quarter, April to June 2022. An overview of the reports completed, lists the recommendations for no charge, disciplinary action or charge. Recommendations from fatal shooting incidents, where Commission's Reports were completed as well as rulings by the Office of the Director of Public Prosecutions (ODPP) during the quarter are also listed. Three (3) members of the Jamaica Constabulary Force (JCF) was charged during the period, for incidents investigated by INDECOM.


PART THREE: PUBLIC INFORMATION


NEW COMPLAINTS: APRIL – JUNE 2022

- * Assault includes assault occasioning bodily harm and assault at common law


Graph 1 shows the 304 categories for the 241 new incidents for which complaints were received by the Commission during the period April to June 2022

COMPLAINTS BY PARISH




Graph 3 shows the breakdown per parish for the 241 new complaints received by the Commission during the period April to June 2022



1.	May 27, 2010	Jermaine Clarke	On the 27th day of May 2010 the deceased raped an exotic dancer at the Players Night Club. The matter was reported to the police and during a patrol of the area the police spotted two men along the Shooters Hill Main Road. The men opened fire on the police and the fire was returned. The area was searched where the deceased was found suffering from gunshot wounds. He was rushed to the Mandeville Regional Hospital where he was pronounced dead.	No Charge
2.	January 19, 2012			No Charge
3.	January 5, 2013	Ricardo Allen	The police claimed they were responding to a report of someone breaking into a motorcar in 5 East, Greater Portmore, St. Catherine, when they intercepted a motorcar with three armed men who opened fire at the police. A shootout ensued in which one of the men was shot and injured. The injured man was taken to the Spanish Town Hospital where he was pronounced dead.	No Charge
4.	January 11, 2013	Craig Carty & Troy Brown	On Friday, January 11, 2013 at about 7:45 p.m. a team of police officers were on mobile patrol in the Port Henderson area when they received information that caused them to detour to Fort Augusta Drive. They parked the vehicle near to the entrance of the road and moved in the direction of the prison. They reportedly saw a group of men who engaged them in a shootout. After the shooting subsided, two men were found suffering from gunshot wounds. They were transported to the Spanish Town Hospital where they were pronounced dead. A 9mm semi-automatic pistol, a magazine containing seven live 9 mm rounds was recovered near the men. There are no eyewitnesses in this matter.	No Charge
5.	February 24, 2014	Osheda Barrett	On February 24, 2014 Constable was driving along Esher Main Road, when his car developed mechanical problems. He further stated that he pulled over and stopped to make checks when he was pounced upon by two men whom pointed a firearm at him. Constable allegedly pulled his pistol and fired twice hitting one of the men. One allegedly ran whilst the other fell on to the ground. A home-made shotgun was allegedly found beside him as well as a knapsack containing a .38 revolver. It is further alleged the Constable brought them to the Highgate Police Station where he made a report. The police allege that they went to the scene and saw a man lying on the ground who was rushed to the Port Maria Hospital where he was pronounced dead.	No Charge

6.	April 11, 2015	Rhea Ricketts	On Saturday, April 11, 2015 deceased Rhea Ricketts journeyed to Nairne Castle, in May Pen, Clarendon with her Common Law husband, Constable. The two (2) were to pick up their sons J Jr. and J from Rhea's parents. Constable and Rhea arrived at the house and following conversations with Rhea's parents and the family, Constable went to a bedroom and decided to take a nap as he was tired. He placed the service Glock pistol in his possession underneath a pillow, rested his head on the pillow, and fell asleep. Rhea and the children were also in the room prior to him falling asleep. Some moments later there was a loud explosion sounding like a gunshot, and Constable was awakened. He awoke to see Rhea with a gunshot wound to her head crouching over J Jnr. stumbling, and then falling to the floor and their son J Jnr seated at the end of the bed with the firearm between his legs on the floor. Rhea's family present in the house were alerted by the sound of the loud explosion and rushed to the bedroom she had been in, and discovered her body on the floor with blood around her and a wound to her head. She was later removed from the room and taken to the Spauldings Hospital where she was pronounced dead.	No Charge

July 31, 2015	Warren Rodney	On Friday, July 31, 2015 at about 5:50 a.m. at White Lane, Kingston 11 a police party were on operation in the Tower Avenue are, Kingston 11 when they received certain information. As a result of the information, the team was divided into two. A team consisting of Corporal, two Constables and District Constable came to the location on White Lane. The police came and knocked on the door, shouted police. A lady opened the door and came out to the police. She was asked, who else was in the house, she replied "me and me baby alone." She stepped out of the house, Corporal upon entering the house, looked inside to the right, saw a dresser, looked in the mirror and saw a man stooping in the corner. He shouted "police, get up!" The man stood up and pointed a firearm in the direction of the police. The police opened gunfire hitting the now deceased. He was assisted to K.P.H. by police personnel where he was pronounced dead. There are no eyewitness in this matter.	No Charge
8.	February 28, 2016	Omar Francis	On Sunday, February 28, 2016 at about 10:30 a.m. a joint team from C-TOC and Mobile Reserve were on guns for drugs enquiries in Clarendon, as a result they were in the Woodleigh area to covertly meet with a man known as 'Rasta' to purchase a firearm. The team was divided in three (3) groups and a White Toyota car turned up and a rasta man from the car approached one of the unmarked Police vehicle, brandished a gun and said, 'bumbo hole gi mi de money'. The driver of the police vehicle fired one (1) shot in the rasta man's direction and he fell. The White Toyota car sped off and when another team tried to intercept it the occupants opened fire at them, the fire was returned and the car sped away. The injured rasta man was pronounced dead at May Pen Hospital.	No Charge
9.	February 3, 2017	Cardio Russell & Nicholas Robinson	On February 3, 2017 at approximately 9:40 pm, a special Operations Team from the Area Four Division received information that men travelling in a white Nissan AD Wagon with guns were heading to Portmore. The team were on enquiry on the Toll Road when they observed a motor vehicle fitting the description. They signaled the men to stop and the men complied. On approach of the Police the men opened fire. The Police returned fire and two of the men exited the vehicle and escaped. Two men were later found in the vehicle suffering from	No Charge

10.	September 20, 2018	Andre Perrier	On Thursday, September 20, 2018 at about 2:45 p.m. Constable who was off duty at the time received a report from GC o/c 'S' that his bar was broken into. Constable then went into the Martha Brae community where the bar is located accompanied by GC and his girlfriend. Both GC and his girlfriend pointed out the man who had broken into the bar to Constable. This man was known to them as Oshane. Constable approached Oshane and identified himself as police officer by using his police identification card. Constable tried to lay hold of Oshane. Oshane then pulled away from Constable and picked up a piece of iron. Oshane attacked Constable with the piece of iron by swinging it at him. Constable pulled his service pistol and warned Oshane to drop the piece of iron, however, he refused to do same. Constable then discharged two rounds from his service pistol in Oshane's direction. Oshane ran off and fell at some distance in a shop. Oshane was assisted to the Falmouth Hospital where he had died whilst undergoing treatment.	No Charge
11.	October 16, 2018	Calvin Eubanks	On Tuesday, October 16, 2018 about 11:20 a.m. Sergeant and Constable of the Croft Hill Police Station were on mobile patrol and whilst traveling along the Reckford Main Road they saw Calvin Eubanks who they knew before and for whom a warrant of arrest was out for. The driver of the vehicle Sergeant stopped the vehicle beside Eubanks, informed him of the warrant to which he replied, "mi a god up yah so weh yuh a come tell mi bout warrant". Both officers alighted from the vehicle and Eubanks ran off into nearby bushes, the officers did not chase him. They re-entered the vehicle and continued on the patrol, drove to Reckford Square, turned the vehicle and was heading back to Crofts Hill when they again spotted Eubanks. Eubanks who was armed with a machete ran towards the service vehicle and pushed the machete towards the neck of Sergeant who had to jump over onto Constable to avoid being stabbed. Sergeant then drew his service pistol and fired one round but Eubanks continued his attack, stabbing Sergeant to the right bicep with the machete, by which time the service vehicle was shut down and turned across the street. Sergeant in fear of his life discharged several rounds in quick succession in the direction of Eubanks, who subsequently walked to the back of the service vehicle and fell. Both officers took up Eubanks, placed him in the back of the service vehicle and took him to Chapelton Hospital where he was pronounced dead and Sergeant treated and released.	No Charge
12.	January 27, 2020	Shawayne Armstrong	On Monday, January 27, 2020 at 3:30 p.m. the police were on mobile patrol in the Darling Street police area. The team was proceeding along Spanish Town Road when on reaching the vicinity of Bond Street, the now deceased was driving a grey 2013 Toyota Probox motorcar registered 081HY committed a breach of the Road Traffic Act. Constables confronted the now deceased during which Cons. A wrote him a ticket for the breach. Upon completion of writing the ticket the now deceased grabbed his motor vehicle documents from Cons. A and returned to his motorcar leaving the traffic ticket. Cons. B instructed him to collect his ticket, however he refused and put the motorcar he was driving in motion. Cons. B instructed the now deceased to stop, however, he allegedly used the vehicle to hit Cons. B causing him to fall against the bonnet and	No Charge

further attempted to mow him down. Cons. B in defence of his life and safety quickly pulled his service glock pistol and discharged one (1) round in the direction of the now deceased hitting him in the region of his neck. Citizens then quickly converged on the scene and began behaving in a hostile and boisterous manner towards the police who were attempting to assist the now deceased to the hospital. The now deceased was taken to the Kingston Public Hospital where he was pronounced dead on arrival by Dr. at 3:50 p.m. The sole eyewitness the sole passenger in the motor car gave an unsigned account on the night of the incident. This witness has since refused to give a statement despite efforts. 13. February 19th, 2020 Kerr On February 19th, 2020 The Independent Commission of No Charge as per Keemo and Kemoy Smart Investigations ('the Commission') commenced DPP ruling dated 4th April 2022 investigations into the fatal shooting of Kemoy Kerr and Kemoy Smart and the Shooting Injury of TA. All incidents occurred in the Mud Valley community. This Report will address each complaint separately but for the purposes of this report, the complaints are joined owing to the connection of the events. In relation to the Fatal Shooting of Kemoy Smart, eye witnesses allege that Mr. Smart was shot by the police at a time he was unarmed and posed no threat to the officers. The Concerned Officers however allege that Mr. Smart pointed a firearm at them and in defence of their life, they returned fire. A firearm was recovered from Mr. Smart. In relation to Fatal Shooting of Keemo Kerr, the Concerned Officers reported that while on foot patrol along Jetty Lane, Mr. Kerr was among five men standing at a board shop all armed with firearms. The police instructed the men to drop their firearms and they fired at the police. The police returned fire at the men. Mr. Kerr mounted his motorcycle and rode away on his motorcycle towards Mud Valley main road. While on the roadway, Mr. Kerr met upon another team of policemen. When instructed to stop, he pointed a firearm at the police, and in defence of their lives, Constable fired at Mr. Kerr. He fell from his motorcycle which crashed in the unmarked service vehicle. A firearm (shotgun) was recovered from his person. In relation to the Shooting Injury of TA, about midday while he was speaking with his friends at "Bunny's" yard, he heard explosions coming from the direction where Keemo rode away followed by "crashing sounds". In fear, he ran away. While running, he looked behind him and saw a man who he knew to be a police officer. The officer, who was about 12 to 15 ft. from him, pointed the rifle at him and he immediately felt a shot to the right side of his back. The Concerned Officers allege that TA was among the men who engaged them along Jetty Lane. 14. May 26th, 2020 Jeffrey Robinson On May 26th, 2020, The Independent Commission of No Charge Investigations ('the Commission') commenced investigations into the fatal shooting of Jeffrey Robinson aged fifteen years old. The police reported that on May 26, 2017 about 10:00 p.m. Detective Corporal and Constable were on patrol in Mud Valley, Retirement, St. James when they came under aunfire from a group of men. They sought assistance and another Constable joined their unit. The men opened fire on the officers again and they returned fire. One man was found suffering from gunshot wounds and taken to the Cornwall Regional Hospital. A firearm was recovered from his person. He was pronounced dead by Dr. He was later identified as Jeffery Robinson, fifteen years old, D.O. B. June 16, 2001. One single action (make unknown) firearm with serial number 73C80343

			containing five live cartridges was recovered from the scene. Civilian eye witnesses refute the officers' allegations and contend that the police pounced upon the group of individuals and began shooting at them. One eye witness suggests that Mr. Robinson was killed execution style after he pleaded for assistance.	
15.	. June 15, 2020	Savyan Hinds	On June 15, 2020, sometime after 11:00 a.m., police personnel inclusive of Constable and Woman Constable of the Port Maria Police Station, proceeded to the residence of Savyan Hinds in Fernandez Gardens in Stewart Town, St. Mary with the intent to search his dwelling. Savyan, who was a person of interest at the time, was escorted into the house and taken inside his room by both concerned officers. There were no other persons inside the room except the mentioned individuals. PH, the sister of the deceased and who was at home at the time of the shooting, indicated that Savyan's hands were handcuffed behind him upon his arrival at the premises and that he was taken to the back room by four police officers including one female officer. Thereafter, she heard three loud explosions sounding similar to those of gunshots followed by three further explosions about two seconds later. She then heard Savyan cry out. Savyan was taken to the Port Maria Hospital where he was pronounced dead on arrival. A Taurus pistol, alleged to be in the possession of the deceased, was recovered from by the police. July 27, 2020	Romain Cunningham	On Monday, July 27, 2020 at about 5:30 p.m. the police were on mobile patrol in the Riverton City area when they received information that a group of men were planning to burn down a house in the area and kill the occupants. They parked their motorcycles and went on foot in search of the men. They saw a group of about seven heavily armed men coming in their direction. District Constable shouted "Police don't move". The men immediately opened gunfire in the direction of the police officers who took evasive action and returned fire in the direction of the men. After the shooting subsided two men were seen suffering from gunshot wounds and one Smith & Wesson 9mm pistol with serial number containing two 9mm rounds was found. Both men were transported by the police to the Kingston Public Hospital where RW was treated and admitted in stable condition for gunshot to his right upper arm. Romaine Cunningham was pronounced dead on arrival by Dr. at 6:11 p.m.	No Charge
17.	September 12, 2020	Worrel Brown & Carl Gauntlett	On Saturday, September 12, 2020, that at about 11:50 a.m., police officers, all attached to the St. Mary Operational Support were on patrol in the Iteboreal area of Annotto Bay. While parked on the roadway doing vehicular spot checks, they saw a grey Honda motor car, license plate# 5734HS heading in the direction of Annotto Bay and they signaled the driver to stop. The driver disobeyed the signal and continued to drive. The police team, became suspicious and went in pursuit of the same car. While driving behind the car, they continued to signal the driver to stop and he refused but the police managed to intercept the vehicle on the Agualta Vale main road. The team of officers exited their vehicle and while approaching the car, they were fired upon and the gunfire was returned by the police. When the shooting subsided, two men were found inside the car suffering from gunshot wounds. A Sigsauer 9mm pistol with a magazine containing six (6) live rounds and serial number erased was recovered from the floor of the front passenger seat. The injured men were rushed to the Annotto Bay Hospital where they were pronounced dead on arrival.	No Charge

Indeed, such a position is supported by the witness evidence gathered by the Commission. AD was grazed by one of the bullets fired by Constable as, he was a passenger in the front of the 2010 Toyota Voxy which was being driven by the deceased in a manner calculated to intimidate the concerned officer. Having investigated the matter, the Commission has found that no prima facie case of murder has been established.	No Charge
