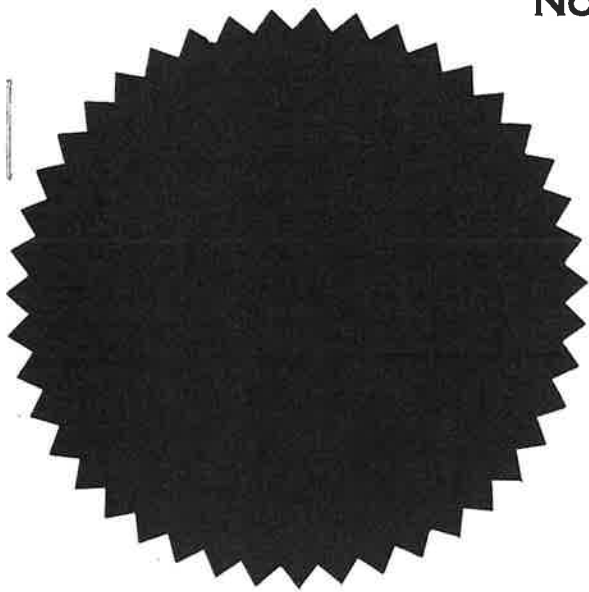

AN ACT to Amend the Political Ombudsman (Interim) Act
and to provide for connected matters

[13th day of February 2024]

BE IT ENACTED by the King's Most Excellent Majesty, by and with
the advice and consent of the Senate and House of Representatives of
Jamaica, and by the authority of the same, as follows:—

1. This Act may be cited as the Political Ombudsman (Interim)
(Amendment) Act, 2024, and shall be read and construed as one with
the Political Ombudsman (Interim) Act (hereinafter referred to as the
principal Act) and all amendments thereto.

Amendment

2. Section 4 of the principal Act is amended by deleting subsection (2) and substituting therefor the following—

“ (2) The Electoral Commission of Jamaica established under the Electoral Commission (Interim) Act shall be the Political Ombudsman.

Repeal of
sections 5, 6,
7 and 8

3. Sections 5, 6, 7 and 8 of the principal Act are repealed.

Repeal of
section 9 and
First Schedule
of principal
Act.

4.—(1) Subject to subsection (2), section 9 and the First Schedule of the principal Act are repealed.

(2) Notwithstanding the repeal of section 9 and the First Schedule of the principal Act, those provisions shall continue to apply in respect of the payment of pensions and other benefits to any person entitled, as on the date immediately preceding the repeal, to receive such payments.

5. Section 12 of the principal Act is amended in subsection (2) by deleting the numerals “25” and substituting therefor the numerals “19”.

6. Section 19 of the principal Act is repealed.

Repeal of

7. Section 25 of the principal Act is repealed.

Amendment
of Second
Schedule of
principal Act.

8. The Second Schedule of the principal Act is amended by inserting next after the words “Political Ombudsman” the word “(Interim)”.

Amendment
of
the Electoral
Commission
(Interim)
Act.

9. The Electoral Commission (Interim) Act is amended in section 6(1) by—

(a) deleting (a) deleting the full stop appearing at the end of paragraph (v) and substituting therefor a semi-colon; and

(b) inserting the following as paragraph (w)—

“(w) be the Political Ombudsman under the Political Ombudsman (Interim) Act.”,

and the amendments shall be read and construed as one with the Electoral Commission (Interim) Act.
