

ANACT to Amend the Financial Administration and Audit Act.

[15th day of November, 2016]

BE IT ENACTED by The Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and House of Representatives of Jamaica, and by the authority of the same, as follows:--

1. This Act may be cited as the Financial Administration and Audit Short title (Amendment) Act, 2016, and shall be read and construed as one with and the Financial Administration and Audit Act (hereinafter referred to as the "principal Act") and all amendments thereto.

2. Section 24B of the principal Act is amended by deleting subsection Amendment (1) and substituting therefor the following—

of section 24B of principal

- (1) Government accounts which are required under this Act to be published shall be prepared in accordance with-
  - (a) internationally recognized accounting principles;

- such instructions as may be issued by the Financial Secretary under section 51; and
- (c) such regulations as may be prescribed.".

Amendment of section 24G of principal Act.

- 3. Section 24G of the principal Act is amended in subsection (1) by deleting the full stop appearing at the end of paragraph (d) and substituting therefor a semi-colon and the word "and" and inserting next after paragraph (d) the following paragraph—
  - " (e) the General Purpose Financial Statements in accordance with the International Public Sector Accounting Standards.".

Amendment of section 24H of principal Act.

- 4. Section 24(H) of the principal Act is amended in subsection (1)—
  - (a) by renumbering paragraph (k) as paragraph (1);
  - (b) by inserting next after paragraph (j) the following paragraph—
    - "(k) information set out in the General Purpose Financial Statements under section 24G(l)(e);"; and
  - (c) in paragraph (1), as renumbered, by deleting the words "(a) to (i)" and substituting therefor the words "(a) to (k)".

Amendment of section 241 of principal Act.

- 5. Section 24I of the principal Act is amended by deleting subsection (2) and substituting therefor the following—
  - " (2) The statements mentioned in subsection (1) shall—
    - (a) include General Purpose Financial Statements in accordance with the International Public Sector Accounting Standards;
    - (b) be certified by the Auditor-General; and
    - (c) be laid on the Table of the House of Representatives.".

Amendment of section 48C of

6. Section 48C of the principal Act is amended in subsection (1)(c) by deleting the words "March 31, 2016" and substituting therefor the principal Act. words "March 31, 2019".

7. Section 51 of the principal Act is amended—

Amendment of section 51

(a) by deleting the words "The Financial Secretary" and of principal substituting therefor the words "Subject to section 24B, the Financial Secretary"; and

(b) in paragraph (c) by inserting immediately after the words "government supplies" the words ", and the accounting standards to be maintained with respect thereto".
