AN ACT to Afford persons a period of reprieve to address outstanding matters related to prescribed notices issued prior to February 1, 2023, under section 116 of the Road Traffic Act, 1938, and to nullify demerit points recorded against all driver's licences prior to February 1, 2023.

BE IT ENACTED by The King's Most Excellent Majesty, by and with the advice and consent of the Senate and House of Representatives of Jamaica, and by the authority of the same, as follows:—

1. This Act may be cited as the Road Traffic (Reprieve and Short title. Nullification of Prescribed Notices) Act, 2023.

Interpretation. **2.** In this Act, unless the context otherwise requires—

“outstanding traffic penalty” means the fixed penalty in respect of an offence to which section 116 of the Road Traffic Act, 1938, relates that would have been payable, pursuant to a prescribed notice issued during the period commencing on February 1, 2018, and ending on January 31, 2023, before the end of twenty-one days following the date of the notice or such longer period (if any) as may be specified in the notice;

“prescribed notice” means a notice issued under section 116(2) of the Road Traffic Act, 1938, in respect of an offence to which that section relates;

“qualifying person” means any person who was served a prescribed notice;

“reprieve” means the relief set out in section 4(2);

“reprieve period” means the period commencing on February 1, 2018, and ending on January 31, 2023.

Declaration  
of reprieve.

**3.** Subject to the provisions of this Act and notwithstanding any provision to the contrary in any other enactment, a reprieve is declared whereby, for the duration of the reprieve period, a qualifying person who pays an outstanding traffic penalty in accordance with section 4 shall be entitled to the relief specified in that section.

Scope of  
reprieve.

**4.—(1)** A qualifying person who, during the reprieve period, pays an outstanding traffic penalty, into the Traffic Court, shall be entitled to the relief set out in subsection (2).

(2) The relief referred to in subsection (1) is that the qualifying person shall not be liable to be convicted of the offence in respect of which the qualifying person has paid the outstanding traffic penalty and proceedings shall not be taken against the qualifying person for that offence.

5. Notwithstanding section 59B of the Road Traffic Act, 1938, where an outstanding traffic penalty has been paid, all demerit points recorded against the licence of a qualifying person, pursuant to section 59A of the Road Traffic Act, 1938, in respect of the offence concerned, shall be treated as nullified and shall be expunged from the records.

Nullification and expungement of demerit points.

6. All prescribed notices issued before February 1, 2018, for which payment of outstanding penalties have not been made are hereby rendered void and of no effect.

Nullification of prescribed notices issued before February 1, 2018.
